DESCRIPTION

Pure Silicone[™] sealant is a specially formulated, neutral-cure, 100% silicone sealant for a variety of substrates such as ceramic tile, slate, wood, metal, glass, fiberglass, laminate and plastic. For use as a flexible barrier between horizontal and vertical surfaces or any other changes in plane such as expansion joints in non-traffic areas, fixtures, tub surrounds, sinks, toilets, vanities, electrical plumbing penetrations, floors, walls and ceilings. Pure Silicone[™] is designed for use in interior, exterior, intermittent wet and dry installations. Pure Silicone[™] has superior elongation and flexibility for use in change of plane joint applications. Pure Silicone[™] sealant meets or exceeds the test requirements of:

- Meets ASTM C-920; Type S; Grade NS; Class 25; Use A, G, I, M, NT O
- Federal Specification TT-SS-0001543A (COM-NBS) Class A, Type NS, Class A, Use G
- Federal Specification TT-S-00230C (COM-NBS) Type II, Class A, Use G

WHERE TO USE

Interior/exterior vertical or horizontal surfaces and intermittent wet.

DIRECTIONS FOR USE

Read and understand technical and safety data sheets completely before beginning installation. Follow applicable ANSI, NTCA and TCNA installation standards. Refer to www.bostik.com/us for the most recent product information and safety data sheet prior to installation.

SURFACE PREPARATION

All surfaces must be structurally sound, clean, free of dust, dirt, oil, grease, water, curing compounds, sealers, waxes or any contaminants that may inhibit proper bond. TCNA recommends roughing or scarifying glazed tile substrates.

NOTE: It is the user's responsibility to determine the condition and suitability of all surfaces before application.



APPLICATION

Mask both sides of the joint. Remove tip-cover, cut tip on a 45° angle to desired diameter and puncture the seal inside the tube. Place in a caulking gun and apply using steady, even pressure to completely bridge joints. Smooth by dry tooling the bead and remove masking tape immediately. Wipe off any sealant on the face of the veneer with a paper towel before surface sealant skins over. Excess sealant should be removed before curing. Application temperature range is -35° F (-37° C) to 160° F (71° C).

CLEAN UP

Clean all tools and equipment immediately with mineral spirits while sealant is uncured.

COVERAGE

Coverage will vary depending upon joint size and width. 10.1 fl.oz. covers 50 linear feet with a 1/16" bead.

PACKAGING

10.1 fl. oz. (300 mL) cartridges, 6 and 12 cartridges per case

STORAGE/SHELF LIFE

Store in a clean, dry area not affected by freezing or hot temperatures between 50°F (10°C) and 90°F (32°C). Shelf life is one year from date of manufacturing in unopened cartridge.

VOC

40 g/L (as calculated per SCAQMD 1168).

LIMITATIONS

- Service temperature range -40°F (-54°C) to 300°F (149°C).
- Do not use in areas where joints will be subject to heavy abrasion or wear.
- Product may stain porous materials. Test a small area for staining or leaching before use with porous material, such as natural stone.
- Do not use for structural glazing.
- Product should not be used in areas where material may come in contact with plasticizers or other materials that will prevent adhesion.
- · Not for use in submerged areas.
- For joints with depth greater than 1/2" (12 mm), the caulking depth must be controlled by a closed-cell backer rod.
- The sealant depth should be between 3/16" (4.8 mm) and 1/2" (12.7 mm).
- · Not paintable.
- Check for compatibility with natural stone products.
- · Releases a small amount of acetic acid during use.
- · Not for use in exterior, below grade applications.
